Bicycle & pedestrian projects totaled **\$1,695,831.28** and include the Menard Ped. Bike Trail, LA 24 Sidewalk Rehab, and the Civic Center Sidewalks. Bridge Projects totaled **\$1,955,215.85** and includes the Robinson Canal Bridge, the LA 653 Bayou Dumar Bridge Replacement, various emergency and storm related repairs, and several other repairs/replacement projects.

Regional transit funding is reported in National Transit Database by local agencies including the Assumption Council on Aging, the Terrebonne Council on Aging, and Good Earth Transit (Terrebonne Parish). The various councils on aging provide a mix of rural demand-response service and elderly/disabled paratransit services. Good Earth Transit provides fixed-route and para-transit service in Terrebonne Parish and the City of Thibodaux.

In total, the region reported annual operating expenses of **\$2,695,755** and **\$74,954** of capital expenses. These efforts went to providing nearly 128,000 trips in 2019.

As a whole, the transit system was greatly affected by the COVID-19 pandemic. Trips were down 43.9% with total revenue hours operated down 21.6%. This trend is anticipated to continue through the 2021 and 2022 NTD reports.
