# 3. Occupant Protection (OP) Emphasis Area

# a. Action Item Updates/Discussion

C. Parker reviewed the updated data provided by LADOTD, Highway Safety Research Group, and Law Enforcement Agencies. In 2017 there were 26 fatalities, 44% increase. N. Soudelier relayed the Galliano Library held a CPS event where (4) seats were checked. Upcoming CPS events to be held at the Walmart in Thibodaux, Barker Honda in Houma, and Walgreens in Morgan City. High traffic locations are being targeted for CPS events. "Buckle Up Louisiana" shares all CPS events information through their social media accounts. It was suggested to utilize Facebook ads which targets demographics of the advertisers preference. J. Hill agreed to research funding sources for the utilization of Facebook ads for CPS events. R. Dantin of LPSO has recently become a certified CPS instructor, giving the Region (2) certified CPS instructors. A Regional Child Passenger Safety Occupant Protection Awareness Course will be held on June 4<sup>th</sup> at SCPDC office in Houma, information is forthcoming. A 2<sup>nd</sup> course is being planned for later in the year in St. James Parish. Please promote "Buckle Up in Your Truck" during the month of April and "Click it or Ticket" during the month of May.

### b. Maternal & Child Health CAAT Coalition

N. Soudelier relayed the first meeting of the Maternal & Child Health CAAT Coalition was held in September 2017. She explained the goal of the MCHCCAAT was to promote optimal health of families within the Region by ensuring quality service delivery, reduction of injury and death. Meetings are held on a quarterly basis and SCRSC members are invited to attend. The next meeting will be held in May 2018. Within the meeting packet for Coalition members to review was the Regional 3 Mortality Surveillance Report, 2013-2015.

# c. LA Highway Safety Commission Observational Survey

The 2017 Louisiana Seat Belt Observation Survey results were included within the meeting packet for Coalition members to review. The Houma region had a decrease of 3.5% points which is statistically significant. Concerns on how the data was collected and which information was viable to the survey pertaining to rural areas and farming truck occupants being exempt from seat belt use was discussed. C. Parker stated she will bring the concerns to the Statewide Meeting for discussion.

# d. Saved by the Belt Nomination

Nominations are needed. In order to be considered for nomination the nominee must meet the

# 4. Impaired Driving (ID) Emphasis Area

# a. Action Item Updates/Discussion

D. Bergeron reviewed Strategies under IDEA. He stated Lafourche Parish and Troop C held a DWI checkpoint in February, Houma PD held one in March. LPSO plans to hold another May 31st and LPSC plans to hold a checkpoint in June. "Zero for December" has been expanded to include the Holiday Season "Zero for the Holidays" beginning the campaign at Thanksgiving all the through New Year. They plan to create a Task Force beforehand to help push forth campaign efforts. The DWI BAT mobile has been utilized in parades and at mock crash events. Captain Besson has been working on building relationships with local District Attorneys. J. Rodrigue suggested MADD speakers to meet with Judges and District Attorneys. It was also suggested to add MADD speakers to the "Zero for the Holidays" events.

### b. LDAA Drugged Driver Training

The Louisiana District Attorneys Association is offering a course on "Prosecuting the Drugged Driver" to be held on May 16-18 at the Embassy Suites Hotel in Baton Rouge, LA.

# 5. Young Driver (YD) Emphasis Area

# a. Action Item Updates/Discussion

J. LaGrange briefly reviewed the Strategies for YDEA. "Buckled Up" Seatbelt Checkpoint event will be held on April 20<sup>th</sup>. Ellender High School and South Terrebonne High School participated in the "Buckled Up" Seatbelt Checkpoints. Trying to organize three more events before the end of the school year. Lutcher High School was awarded first place for the "Capturing Safety through the Eyes of the Teen" Contest. J. LaGrange plans to reach out to NSU over the summer to set up traffic safety presentations during the fall semester. C. Parker requested feedback on the possibility of reaching out to NSU's Marketing/Media students to create a campaign for Distracted Driving and utilizing grant funds to implement the campaign. B. Zeringue stated he would reach out to them. J. LaGrange relayed that overall 58 presentations events were held, 2,059 people were addressed; whereas, 1,677 of those were young drivers. C. Parker stated she will email the PDF version of the GDL card to members.

# b. LA Highway Safety Commission – Grant Opportunity

J. Hill informed the Committee that Ford Motor Co. and GHSA has offered a \$15,000 grant opportunity to State Highway Safety Offices. Each Region would be allowed to do a young driver's video competition. If awarded, the monies would be allowed to be used as mini grant opportunities for the video winners in each region and promotion of the videos. The video must encompass Ford's focus areas of: Hazard recognitions, vehicle handling, speed and space management, and distracted and impaired driving. The deadline has been tentatively set for October/November 2018. J. Hill will be drafting the application for submission and will send out for feedback.

#### c. Shell & State Farm Promotional Items

The Coalition has received grant funding for promotional items geared toward Young Drivers. These promotional items are available to any agency which have presentations or programs that support any of the Young Driver campaigns. Contact C. Parker if interested in these items. Documentation on how and who are utilizing these items are a must.

C. Parker stated included in the packet was the Graduated Driver's License Laws for parental reference.

# 6. Distracted Driving (DD) Emphasis Area

### a. Definition of Distracted Driving

A State meeting will be held in June to begin discussion on Distracted Driving Strategies, Action Plans, and such. Distracted Driving is defined as "a distracted or inattentive driver is one who is actively engaged in any activity that diverts his/her attention away from the task of driving. The distraction could be manual, visual, or cognitive and be inside or outside the vehicle." Any ideas/suggestions on how to reach out to the public will be greatly appreciated.

### b. Legislation of HB 619: Prohibits use of wireless communications devices while driving

For informational purposes included within the meeting packet was the 2018 Legislative Summary. Discussion ensued on the difficulty LEO's face in ticketing or proving wireless communications devices are being used while an individual is driving.
