a. Current DOTD Project Updates

J. Oncale updated the Policy Committee on the following projects:

Lafourche Parish:

- LA-1 Phase 2, Leeville to Golden Meadow is 15% complete. Contractor is driving piles.
- LA-648 Percy Brown Road Overlay construction has begun. Contractor is finishing paving on Monday, they are beginning guardrail on May 4th and prepping following.
- LA-308 from Golden Meadow Bridge to Galliano Bridge construction has begun. Contractor is trimming trees and starting patching.
- Acadian Road Roundabout is currently in the assembly period. Contractor is locating utilities.
- LA-307 Overlay has been awarded and is awaiting an evaluation.
- LA-3220 Movable Bridge has been awarded and is awaiting evaluation.

Terrebonne Parish:

- LA-24 Company Canal Bridge Replacement project is 60% complete. Contractor is installing windows and operator house, stairs on the south tower, and machinery deck.
- LA-24 Overlay from Ducros Road in Schriever to St. Charles Street in Houma, is approximately 99% complete. Contractor is putting up final signage.
- LA-665 Overlay from Oak Point Road to Point Au Chene Marina is 85% complete. Contractor is putting in mailboxes, driveways, and striping.
- LA-24 Northbound from St. Charles Street to St. George Road is 13% complete. Contractor is patching the concrete patching and asphalt patching will begin next week.
- LA-20 Overlay from Ducros Road to LA-648 is 99% complete. Contractor is working on fixing some drainage.
- LA-661 has been awarded and is currently in the assembly period. Will begin construction in Mid-June
- LA-24 sidewalk rehab is complete 80% complete. Contractor is installing handrails, signage, and striping.
- LA-56 Robinson Canal Bridge is out for bid.
