Adoption of the January 23rd, 2018 Meeting Minutes

Daigle to approve the Regional Transit Committee meeting minutes of January 23rd, 2018 as amended. There being no objections, motion passed.*

Agenda Item # 3

Guest Speaker – Jonathan Lester of Southeastrans, Inc regarding Medicaid

M. Cazaubon introduced J. Lester to the Committee. Southeastrans is one of three Medicaid brokerage companies in Louisiana. They are currently contracted with two Medicaid Providers, Healthy Blue and AmeriHealth. Southeastrans contracts through the health plans to set up and arrange transportation for members of the health plan who do not have their own transportation. It is Southeastrans job to identify the lowest cost and closest transportation option. They then contact the transportation agency about the client's transportation needs. If a client has a standing order appointment they would then make the transportation provider the sole transportation provider for that client. If it is a demand trip Southeastrans then reaches out to the transportation provider on a case by case basis. Typically the compensation rate is \$7.00 base pickup, \$.75 -\$.80 per mile after 6 miles and ambulatory rate is \$12.00 base, \$1.00 per mile after 6 miles. J. Lester explained a business agreement is required between Southeastrans and the provider. Discussion ensued.

Agenda Item # 4

Training Program Needs – Follow up on Regional Training Opportunities

M. Cazaubon stated she has been meeting individually with each operator to better understand the training needs. Thus far, defensive driving, is the most sought after training. There's a possibility the local community college may be able to offer defensive driving training. She discovered that the training is reimbursable through the HT-MPO and wouldn't cost the transportation providers. M. Cazaubon will begin working on cost comparisons and submit to LADOTD. Once approved by LADOTD she will schedule the training.
